LASTING POWER OF ATTORNEY




A Lasting Power of Attorney ("LPA") allows you to appoint someone you trust to make decisions

Your loved ones would have to apply to Court to make the above decisions on your behalf. This can be an expensive process and will take up more time.

An LPA needs to be submitted online to the Office of the Public Guardian and we can help you with the process.
